



# Shareholder Class Action Lawsuit Against CellCyte Genetics Corporation Is Dismissed

**CellCyte Genetics Corporation** (OTC Bulletin Board: CCYG - News) announced today that a class action shareholder lawsuit initiated against the Company in January 2008 has been dismissed.

This matter was the last of three major adverse legal actions brought against the Company. All three matters are now settled, and no corporate operating funds were paid to any plaintiff or claimant to resolve any of the claims.

With this last legal dispute now settled, the Company's interim principle executive, interim accounting officer and the Company's limited staff can now focus entirely on executing the Company's Interim Operating Plan

This dismissal also applies to both Company co-founders, who were named as co-defendants in by the law suit.
